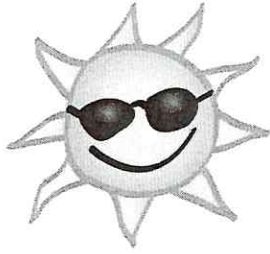

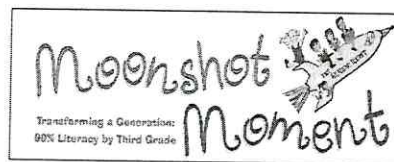

Camp Days and Times:

The Vero Beach Karate Association Summer Camp begins May 28th and ends August 9th. Camp programs run Monday through Friday and we are open at 8 a.m. Activities begin at 9 a.m. to 4:00 p.m. with extended pick up to 5:20 p.m. A three week session leads to promotion in Martial Arts rank.

Along with Martial Arts Training, our campers will participate in Good Manners Workshops, Leadership Training, Music Enrichment, and Ballroom Dancing. Registration Information:

ADVANCED REGISTRATION is necessary for all campers.
A non-refundable registration fee of \$25.00 and \$5.00 per week to hold the weeks requested per family is required to register. Confirmation of registration will be given to the parents with a copy of camp policy and a list of campers needs. Weekly payments are due on Monday. If payments are not made by Thursday, an additional \$10.00 late fee will be charged. ***A copy of birth certificates for 5 year olds must accompany registration*** if camper is not currently a VBKA student.

CAMP COSTS

Single - \$115.00 per week

Family of 2 - \$195.00 per week

Family of 3 & up - \$215.00 per week

These costs include all training and test fees as well as a camp T-Shirt. Campers need to **bring bag lunches.**

Camp Disciplinary Policy

During camp we have several actions we take when presented with discipline problems. Usually just talking to the camper and redirecting them will take care of the problem, but if that does not solve the issue these are the next levels of progression:

First - Verbal warning by the counselor and redirection.

Second - Remove camper from the activity and send to office for a talk with Camp Directors and time out.

Third - Parents called and the problem discussed.

Fourth - Camper is sent home for the rest of the day.

If the discipline problems continue, if the camper poses a safety concern for themselves, other campers, or the staff, the camper will be suspended from camp for one week. Any other infractions will result in expulsion from camp for the rest of the summer.

There is **no refund** for that week if a camper is sent home for disciplinary reasons.

We require these policies to insure our camp is a safe and fun environment for learning for all our campers.
